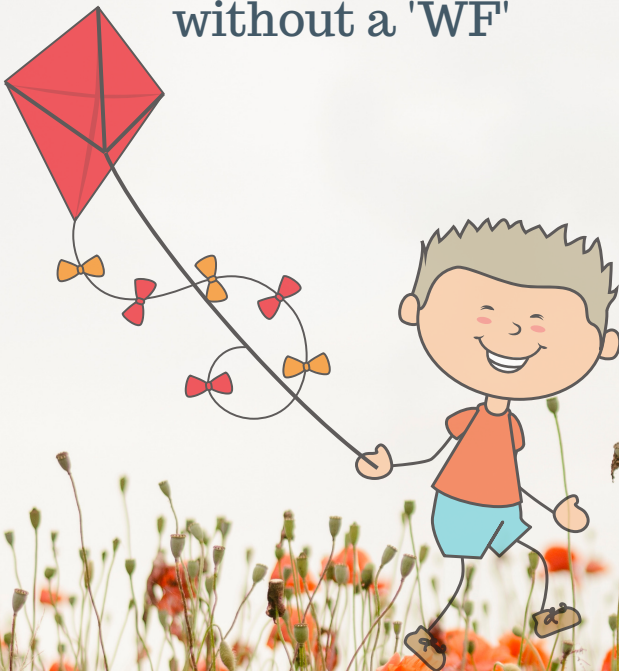

Year-Round Pell

THE ROAD TO FINANCIAL AID

Finish Line to Awarding

Once verification is complete and all Admission requirements are met, you may be awarded any eligible aid. Keep up to date by checking your status on WebAdvisor.

Verification is the confirmation through documentation that the information provided on the FAFSA is correct.

If you are selected for verification, make sure to submit all requested documents.

Submit documentation as soon as possible and allow 1-2 weeks for processing.

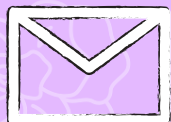
