Good Afternoon!

I hope you three are doing well. As you can see, I am forwarding a request from the Chatham Council On Aging. They are moving ahead with their building plans and are requesting Trustee approval of the attached plans as we indicated would be required. Chairman Philpott is asking that Building and Grounds review the plans and let us know if you have any concerns that need to be addressed. If not, we would like to send to the full board for review prior to discussion and vote to be acted on at a called virtual meeting that Lorraine will be scheduling for December 2, 2020 at 6:00pm.

In addition, I did want to make you aware of some exciting conversations that are taking place. Kirk Bradley, VP Price, VP Roberton and I have had some preliminary conversations regarding the possibility of the CCCC Small Business Center relocating into Mosaic as development of some facilities become complete. Specifically, there will be a building where Innovate Carolina will be managing/coordinating collocated space for economic development. The vision is to organize space and resources that are collocated and designed as a one-stop shop for businesses as they develop and expand. This would be the only arrangement in the state to have all of these pieces in one place, which would certainly lead this to serve as a model for other NC regions. In addition, it would give the college exceptional visibility and great opportunities for future partnerships. VP Roberton, Provost Hall and I are meeting with the Innovate Carolina folks in the next few weeks (virtually) to discuss possible partnership efforts.

I will share more with you and the rest of the Board during the 12/2 meeting, but did want you to know about these conversations and get your preliminary thoughts and feedback. There is great potential for us with this idea.





PROPOSED FLOOR PLANS AND ROOF PLAN








3 WEST ELEVATION - EXISTING






